

2023 Request for Proposals (RFP)

The KC Pre-K Cooperative works to improve Kindergarten readiness by expanding access to high-quality pre-K. As such, the Cooperative aims to expand to serve more students and include additional partners for the 2023-2024 school year. This RFP is intended to identify partners to engage in dialogue and planning to join the Cooperative for the 2023-2024 school year. This RFP invites schools, early education providers, and other community organizations within the KCPS attendance boundary to more formally express their interest in membership in the KC Pre-K Cooperative.

KC PRE-K COOPERATIVE

For the 2023-2024 school year, the KC Pre-K Cooperative invites partners to identify one of three partner tiers that fits with the needs of each respective organization. This tiered model aims to provide organizations with more flexibility to meet the needs of their students, families, and organization to achieve our collective goal of increase access to high-quality pre-K.

KC Pre-K Cooperative Partner Council

The Partner Council includes a representative from each partner organization and meets twice per year. The Council is charged with:

- Providing counsel on strategic direction of Cooperative
- Maintaining integrity of and fidelity to the mission, ethos, and expectations of the Cooperative
- Serving as ambassadors of the Cooperative in the Kansas City region and state

Timeline and Process

Applications will be due on March 1.

After receiving RFP applications, Cooperative staff will facilitate individualized conversations with partners to confirm partnership configurations. The Cooperative will issue a non-legally binding Memorandum of Understanding (MOU) between each partner and the Cooperative. This MOU will be in addition to any MOU formalizing contracted relationships between K-12 and early childhood organizations. Organizations eligible for start-up funding will receive a separate application, which will be reviewed by advisors at the Greater Kansas City Community Foundation. This process will allow for the continued success and ongoing sustainability of the KC Pre-K Cooperative.

- June 1 Cooperative MOU Executed

- Commitment to fully enroll classrooms by July 15 before the start of each school year; commitment to open pre-K seats to the community after August 1


